Overview of Castle Valley Survey Results

The Basics: In the spring of 2007, the Castle Valley Planning and Land Use Commission mailed over 600 surveys to registered voters in Castle Valley as well as to property owners on mailing lists provided by the Castle Valley Property Owners Association that included resident and non-resident owners.

Approximately 287 surveys were returned, of which 272 were used in the analysis, the others being received too late. 151 surveys came from Registered Voters (who can be presumed to be “current residents”). 121 surveys came from Other Property Owners, some of whom are current residents but the large majority of whom are either part-time residents or non-residents.

The members of the Planning and Land Use Commission spent many hours on this project – preparing the survey and analyzing its results. All of us in Castle Valley owe them a big thank you for their hard work and dedication to the project.

A Few Things to Recall:

- Mail surveys are often not representative of the views of total populations because only certain people take the time to fill out such a survey and mail them back. That said, a return rate of nearly 50% is quite good for a mail survey.
- Writing perfect, unbiased questions is very difficult, if not impossible. Individual questions should be approached carefully and should be analyzed in the context of other questions and of written comments in order to really understand underlying opinions.
- “Closed end” questions (i.e. where one ticks off an answer) have the advantage of providing “data” but the disadvantage of sometimes forcing expression of an unformed opinion. “Open-ended” questions (i.e. where people have to come up with their own answers) have the advantage of coming directly from people’s heads, but the disadvantage of being hard to group together and to count.

Basic Findings:

1. **There are some areas where real consensus seems to exist among the survey respondents with few differences of views between Registered Voters and Other Property Owners:**
 - a. **Lot Size:** 97 % of respondents favor keeping the Town’s current 5-acre minimum lot size (with 83% “strongly” in favor)
 - b. **Single Dwellings:** 84 % favor keeping the requirement of one single dwelling per 5 acre lot (with 71% “strongly” in favor)
 - c. **Open Space/ Rural Quality:** In both open-ended and closed-ended questions, there is strong support given for a quiet, non-crowded environment.
 - i. Of those who responded to an open-ended question “What do you like best about life in Castle Valley?”, some 44% wrote of rural

character/privacy/ peace/ quiet and another 36% wrote about views and open space.

- ii. 93% responded positively to a question phrased: “Do you feel that agriculture, livestock, rural character and/or natural landscaping conditions contribute to reasons you have property in CV or live here?”
- iii. 81% said they would support voting on a bond issue to purchase land up-valley for conservation if there were a threat of development. 92% of Other Property Owners favored this v. 71% of Registered Voters.

- d. Water:** Asked to check off areas of “concern” from a long list of issues, water issues were checked most often, i.e. protection of the aquifer (42%), water quality (37%), water quantity (35%), and water rights (35%). Also 72% favored (and only 12% opposed) educating and encouraging the use of non-toxic herbicides and pesticides, and 67% favored (and 21% opposed) requiring new septic systems to meet best available technology standards to protect the Castle Valley aquifer. Nonetheless, some other specific action steps regarding water protection received mixed results:
- i. 54% favored spending money to educate the public on the workings and maintenance septic systems, but only 17% "strongly" favored this and 24% were opposed.
 - ii. Only 45% favored spending money to hire an expert to update the Septic Density study (and 30% were opposed).
 - iii. Only 38% favored spending money to commission a new aquifer and water quality study (and 36% were opposed).
 - iv. More people opposed (43%) than favored (36%) a municipal well.

Interestingly, in nearly all these water-related questions, Registered Voters were significantly more opposed to taking actions than were Other Property Owners. Many people said they were opposed since they didn't know how much money was being considered for these steps.

- e. Roads & Drainage:** 87% of respondents said they would favor increased expenditures on roads and drainage work if that didn't increase taxes. In another question, 80% favored (and only 8% opposed) spending more road money on maintenance to reduce flood damage in the future. Asked to check off areas needing improvements in CV, road quality (11%) and road improvements (10%) received the highest scores. Asked to check off areas needing more spending, road quality was also the highest (10%).
- i. In addition, 66% favor continuing to spend money on education and removal of noxious weeds and only 15% were opposed.

2. There is less consensus and more disagreement on issues relating to ordinances and enforcement, although the general trend is to favor

regulations that address troublesome issues . But Registered Voters are less inclined towards regulatory action than Other Property Owners.

- a. 82% say that they support the current Lighting Ordinance, although there is less “support” (56%) for the Animal Ordinance. In open ended-comments, there were many complaints about barking dogs.
- b. 58% support having a nuisance ordinance while 28% oppose it. Other Property Owners support this at a much higher level (70%) than Registered Voters (48%). Junk/junk cars was mentioned most often (11%) as a negative of living in Castle Valley.
- c. 62% support a maximum square foot limit for new housing while 30% oppose it (giving this issue one of the lowest score for “neutrality” on the survey). Open-ended comments expressed concern about the town being overwhelmed by “rich people” and becoming like Aspen or Telluride.
- d. 55% support limits to square footage for outbuildings while 28% oppose.
- e. 52% support a limit on the number of outbuildings on a lot while 28% oppose. Registered voters show much lower support for this (42%) than do Other Property Owners (64%).
- f. 69% favor restricting the number of animals that can be kept on one 5-acre lot, but there was much less support (46% favor and 33% oppose) for restrictions on boarding other people’s animals. Registered voters are much more opposed to these possible restrictions than are Other Property Owners.
- g. 62% support spending the Town’s money to enforce existing ordinances and 22% oppose. Other Property Owners are more in support of this (71%) than are Registered Voters (55%).
- h. 62% favor say they favor “having fewer ordinances or simplifying its overall set of Ordinances” while 38% oppose. Again, there is a distinction between Registered Voters (who favor this at a level of 71% v. Other Property Owners who favor it at a level of 50%).

3. There is general support for education and encouragement of practices that respond to global environmental issues, with Other Property Owners more positive than Registered Voters, but action steps do not receive broad support..

- a. 64% support (and only 17% oppose) education and encouragement of renewable energy technologies. A smaller 54% favor (and 28% oppose) spending money to have the Town building install solar and renewable energy technologies. Other Property Owners favor these steps more than Registered Voters.
- b. As mentioned above, some 67% support requiring new septic technologies on new dwellings, but a smaller 54% support education to everyone on septic maintenance. Again, Other Property Owners are more in favor of these steps.
- c. There is not strong support (38%) for a commuter van system and an equal number of people (39%) oppose it. Among Registered Voters, 50% are opposed.

4. There are hints in the survey of an openness to more commercial development in Castle Valley

a. While no “closed-end” question addressed this issue, there was an open-ended question: "Please give us your thoughts on commercial and business development in CV". While 24% of comments said "No change"(usually quite adamantly, another 24% suggested small, unobtrusive shops and 21% mentioned the possibility of a coop/ convenience store or a coffee shop (3%).

b. In a closed-ended question, some 54% favored the Town creating more opportunities for community gatherings and the Farmer’s Market (26%) was the most often mentioned possibility. Mentioned second most often was a crafts or arts fair (19%).

5. Respondents want the CV government to provide more information and reduce “town squabbling”. Asked “what suggestions would you make to encourage improved relationships between the Town government and the community”, some 34% of comments called for better information to the community, 27% called for less squabbling and 22% to stop personal agendas. On an open-ended questions about negatives of living in CV, "town squabbling" was mentioned (10%) second only to "Pollution/Junk" (11%).
